Meeting summary

The first meeting of the ALIA Professional Pathways Board 2021 was conducted over Zoom and included discussion of a range of issues including:

1. Meeting in NAIDOC week

The Professional Pathways Board meeting opened with an acknowledgement of country and acknowledgement that the meeting was being held during NAIDOC week.

The acknowledgement stated that the NAIDOC week theme of Heal Country is a call to action. Country is family, kin, law, lore, ceremony, traditions, and language. For Aboriginal and Torres Strait Islander peoples it has been this way since the dawn of time.

Healing Country means embracing First Nation's cultural knowledge and understanding of Country as part of Australia's national heritage and working to ensure the culture and values of Aboriginal peoples and Torres Strait Islanders are respected equally to and the cultures and values of all Australians.

The work libraries and information services still have to do to make this a reality was acknowledged.

2. Conduct of the Board

The ALIA Professional Pathways Board will provide strategic oversight and leadership to ensure the successful development and implementation of the Australian Library and Information Association's (ALIA) Professional Pathways Initiative to deliver a diverse, skilled, valued and supported workforce delivering quality library and information services that anticipate and meet the needs of the population.

The Professional Pathways Board will meet four times a year, with a mix of face-to-face and virtual meetings.

The Terms of Reference and Code of Conduct were endorsed by the Professional Pathways Board.

3. Professional Pathways

The Professional Pathways Board worked through the plan to achieve the objectives of the Professional Pathways Initiative and provided strategic input.

The four year arc of the program was approved as follows:

2021: Consult and develop

2022: Implement

2023: Roll Out

2024: Embed

The Professional Pathways Frameworks project was considered in some detail. This project aims to develop appropriate frameworks to enable alternative options for professional-level entry into the library and information profession, and clear pathways for people to specialise within the library and information profession.

Key milestones in the project are:

Technical paper – presented to the Professional Pathways Board 28 October 2021

Draft Frameworks – presented to the Professional Pathways Board 15 February 2022

Final Frameworks – presented to the Board Monday 16 May 2022 and launched at ALIA National Conference 16-19 May

The ALIA team updated the Board that Dr Gill Hallam has been brought on as a consultant to work with the ALIA team on the project.

The Professional Pathways Board considered the risk register for the project to ensure that all risks were captured.
