Anne Harrison Award Update

Linda Mulheron, the first recipient of the Anne Harrison Award reports that she has completed her survey/questionnaire which forms the first major component of her thesis and the major criterion upon which the Award was granted. Surveys were sent to about 340 libraries, including hospitals, universities, colleges, drug companies and health related institutions. The response to date has been heartening. Over 175 replies have been received so far, of which 140 are usable.



She is presently writing a preliminary paper based on the results for the New Zealand Conference, and will be embarking shortly on the case study component (comprising interviewing of staff and viewing of classes) of her thesis to determine why and how bibliographic instruction programs in health related libraries can be developed.

Linda is happy to report that she receives very good support and assistance in her workplace and is grateful for this.

The Anne Harrison Award Committee wishes Linda continuing progress and success in her valuable project and looks forward to the presentation of the second Anne Harrison Award during the Conference.



The Australian Council on Healthcare Standards, Surveys and Standards Co-ordinator recently contacted the Section regarding the revision of the Library Services Chapter for the 9th edition of the Accreditation Guide. They requested that if we were interested in participating in this working party that we nominate a representative to attend a Working Party which would consider the standards and make recommendations to the ACHS Standards Committee.


The Working Party was held in Sydney and therefore, due to the current transportation difficulties, it was agreed that our nominated representative be resident in Sydney. Monica Davis, Biomedical Librarian at the University of New South Wales, attended the Working Party on the Section's behalf.

The ACHS agreed to take the National Minimum Hospital Library Standards which our Section prepared and ratified in 1987 into consideration during the review.

When this newsletter went to print the editor had not as yet heard the outcome of the Working Party. However, full details will be published as they become available.

A NEW FACE AT THE UNIVERSITY OF QUEENSLAND

Robert Boot, formerly the Chief Librarian at the Royal Darwin Hospital, has accepted the position of Principal Librarian, Health Sciences at the University of Queensland. Robert's base is at Herston Medical Library, Royal Brisbane Hospital and he is responsible for this as well as the three other health sciences libraries which form part of the University of Queensland's library system.

The Brisbane College of Advanced Education's OPAC is available for use by other institutions. The BCAE does not charge for use of its OPAC, but you will have to pay Telecom charges. For those outside Brisbane, this may involve STD rates. The system requires the following hardware, software and telecommunications specifications. Parity: none. Bit setting: 8 data — 1 stop bit. Any standard communications package can be used, terminal emulation is required (ADDS emulation is

best). Virtually all modems on the market are acceptable running either 300, 1200, 1200/75 or 2400 baud.
