#### 2. CONFERENCE NEWS

### 6th Biennial Australian Medical Librarians' Conference, Melbourne 26th-29th August, 1985.

Early indications suggest that our Conference will be well attended. If you are wavering, the Conference Planning Committee commends the programme (which has attracted favourable comment within and outside the profession), the venue, and the fair city of Melbourne, whose weather in August is likely to provide, at the very least, a talking point. Reserved conference accommodation is all within easy walking distance of the venue, and the Top of Collins Street provides ample opportunity for boutique shopping lunch breaks.

Members of the Committee have been in regular correspondence with distinguished international guests Shane Godbolt, from the U.K. and Nina Matheson, from the U.S.A., both of whom are excited at

# 3. L.A.A. GENERAL COUNCIL MEETING, CANBERRA, 29th & 30th MARCH, 1985

Joan Martin attended this meeting as our observer, wearing her Medical Libraries' Section National President's hat, and learned much about the democratic way in which our Association is governed. She was pleased to be invited, along with other observers, to participate in discussion on any item on the Agenda, and discovered that vocal observers can influence the feeling of the meeting, if the President is benign enough to allow them the opportunity! You will be familiar with matters discussed, both through information from State Branch Councils, and from the very full report of the meeting in InCite.

Joan reported that after this experience she had a much stronger impression of cohesion and shared concerns within the organization, and kinship between its many parts. She urges the Section to ensure that it sends an observer to future General Council meetings. She hopes to attend the next meeting in Sydney in August.

#### 4. ANNUAL GENERAL MEETING, WEDNESDAY 28th AUGUST, 1985

A word from our President, Joan Martin -

State Groups are urged to give early consideration to matters for the Agenda of the Annual General Meeting. Time will be limited, as you will see from the Conference program, and I would hope therefore to be able to restrict discussion to items on the Agenda, which might include motions on notice.

A call for Agenda items will be made in late July, and, hopefully, the Agenda and papers will be distributed sufficiently in advance of the meeting to allow prior discussion at States level to occur.

#### 5. DIVISION ELECTIONS

InCite No.11, 12th July, 1985 will contain a call for nominations for the National Executive of the Medical Libraries Section of the L.A.A..

You are reminded that until the Annual General Meeting to be held at the 6th Biennial Conference on Wednesday 28th August 1985, we will not know the location of the 7th Biennial Conference, and you are therefore asked to withhold your nominations until after that meeting.

Any state wishing to bid for the 7th Biennial Conference is asked to consider that possibility well in advance of the A.G.M..

#### 7. STANDARDS FOR HOSPITAL LIBRARIES

Those who follow the activities of General Council will note that, at the meeting on 30th March, 1985, there was discussion on Library standards. The (unconfirmed) minute of this discussion is as follows:-

#### Library standards

Item 21

GC 273/85 asked the Industrial Information & Research Officer to examine the progress on standards for particular types of libraries, and the present proposals to Council

for establishing and/or revising these standards. Council was advised that standards have been published for library services for external students, and multiculturalism in libraries, and policy and performance guidelines for public libraries. Work is to commence on evaluation measures for public libraries, and this will lead to standards. A preliminary draft of special libraries standards has been published, and a second draft is due shortly. No work is being done on university libraries, and some enthusiasm in N.S.W. for college library standards has waned. The Victorian Group of the Medical Libraries Section has prepared Draft Minimum Standards for Victorian Hospital Libraries, and circulated these for comment.

At its last meeting Council abolished the Committee on Standards for Library Services for Handicapped Readers, because of lack of activity but there is now some impetus in this area and it was proposed that the Committee be reppointed, with its title reflecting the current terminology of 'people with disabilities'. The 1984 A.G.M. of the School Libraries Section had raised the matter of standards, and it is understood that some work has commenced with ASLA.

Resolved that the Industrial Information & Research Officer be asked to investigate ways of further assisting the Special Libraries Section in its work on standards.

Resolved that General Council request the President of the Medical Libraries Section, Victorian Group to contact medical library groups in other states to determine whether the Draft Minimum Standards for Victorian Hospital Libraries could be used as the basis for developing national standards for hospital libraries, and that Council offer to assist in the project.

Resolved that General Council notify the University & College Libraries, T.A.F.E and School Libraries Sections, and Sections that would cover joint-use libraries, that it is willing to assist in the development of standards documents, and invite submissions as to how standards could best be developed.

#### Resolved that:-

- the Committee on Library Standards for People with Disabilities be reconvened with Jane La Scala (Convenor), David Barron, Jennifer Berryman, Cliff Law, Valerie Moon and Val Watson as members:
- (ii) the Committee be appointed until the final meeting of General Council in 1986, provided that a satisfactory report is provided for the final meeting of 1985;
- (iii) the Committee be asked to contact the Australian Council for Rehabilitation of the Disabled for its views on the need for library services for people with disabilities.

It is clear that the L.A.A. is treating the question of standards very seriously. The work of the Victorian Group on Draft Minimum

Standards for Victorian Hospital Libraries was commended, but General Council accepted your President's comments (based on your earlier response) that other states generally felt them unsuitable for direct application outside Victoria. The National Secretary has subsequently received a letter from Louise Lansley (L.A.A. Industrial Information and Research Officer) requesting specifically that the Section "discuss the feasibility of developing national standards for hospital libraries, or for other types of medical libraries if this is appropriate."

In response, the Victorian Standards Working Group is about to reconvene. This Group, which now has some experience in the area, is anxious to commence work with other states on the development of national standards, and the National Executive believes it should be possible to establish a nationally-based working group, which should at the very least enrich Australia Post and Telecom.

State groups will shortly be receiving from the National Executive a "call to arms." Accompanying this will be yet another copy of the Draft Minimum Standards for Victorian Hospital Libraries which we hope you will find useful as a basis for discussion on National standards. They were devised for local use, so when the time comes, we hope no-one will be shy about criticising their more general applicability.

We would like to bring together some time during the August Conference in Melbourne the people who are interested in developing National standards, particularly those who are willing to involve themselves with a National working group.

#### 8. CORPORATE PLAN AND REVIEW

The L.A.A. has circulated a letter to all Secretaries with reference to the Corporate Plan and Review Committee. Submissions will be welcomed from all interested parties on this review of the Library Association of Australia.
