




*National Executive

Holdings of Biomedical Serials in Australian Libraries.

During 1997 the extent of holdings of MEDLINE serials in Australian libraries, as recorded on ABN and Gratisnet, has been surveyed.

Background

During the 1970s and 1980s the National Library built an excellent collection of MEDLINE journals, and subscribed to most journals indexed for MEDLINE. In the early 1990s the collection was cut back, then in the mid 1990s, following release of the Library's strategic plan, overseas serials in many subject areas were cancelled. In mid 1997 the Library also cancelled its subscription to the Adonis service, which had provided access to images of over 700 medical journals on CD-ROM. The survey was undertaken to assess the strength of the current medical serial collections in other institutions, and determine how many of the MEDLINE serials were no longer available within Australia.

A listing of current MEDLINE titles was downloaded from NLM, and titles that are indexed only selectively were deleted, to reduce the list to manageable proportions. A total of 2,249 titles were then checked against both ABN and a Gratisnet disk supplied by the National Coordinator. Only current holdings were noted, so that although for some titles there are additional retrospective holdings, these have not been taken into account.

A previous survey had determined that all but a few Adonis titles are held in Australia, but since Adonis is based on the titles of participating publishers, it is not a truly representative sample of journals. MEDLINE titles are selected by a professional review body convened by the National Library of Medicine. MEDLINE is heavily used within Australia, so a survey of holdings of those titles was seen to be a more indicative measure of the level of current collecting activity.

Results

Of the 2,249 titles checked, 14% (315) have no holdings recorded in either Gratisnet or ABN. Although language was not recorded against titles,

it appears that approximately half of these are non-English language titles. An additional 10% of titles had only a single holding in Australia.

It was apparent that quite a number of libraries are still acquiring new titles, as most of the new titles on the list had holdings recorded, and holdings for some established journals started with 1996 or 1997 issues.

51% of all titles are held in Gratisnet libraries, and 16 titles are held only within the Gratisnet system. Approaches are being made to Gratisnet libraries with those unique holdings, seeking permission to record those holdings on ABN. This information will not be made available without their permission, but to date the response has been encouraging.

Only 445 Adonis titles were on the MEDLINE list. In some cases this can be attributed to the wider coverage of Adonis, which includes some specialist chemical journals as well as some generalist titles, which if they are covered by MEDLINE are covered very selectively.

A listing of titles checked is available on request. The list includes abbreviated ABN holdings, state by state. The list indicates in all cases whether titles are held by the major university medical library in that state. Where there are very few holdings, all are listed in the table. There is also an indication of whether the title is held in the Gratisnet system (but no specific locations within Gratisnet are given).


If time permits I would hope to repeat the survey in about two years time, to get some indication of how collecting patterns might be changing over time.

Number not held in Australia:	315 (14%)
Number with one holding only:	214 (10%)

June's post-retirement interests have turned to Biblical studies at Murdoch University and language studies to equip her to teach English as a foreign language in those far off and exotic places she loves to visit.



June's successor is David Dawson.
