The HLS National Executive is now in Victoria, where it will remain for three years. After that it will revert to its normal two-yearly cycle, going first to South Australia (2002-3), and then NSW (2004-5).

Congratulations are due to the Western Australians, who did a fine job of leading the Section over the last three years.

A relatively large committee has been formed in Victoria (details on back page). Part of the reason for this is to give younger ALIA members the opportunity to gain experience at this level. A conscious effort has been made to encourage younger members to accept positions of responsibility - a policy which I commend to state executives.

Readers of this column who are new graduates, or who have a few years of experience behind them, should always consider nominating for HLS Executive positions. Committee work is valuable experience personally and professionally - and your Association really does need your contribution, your ideas, and your fresh approach to professional life.

ANNE HARRISON AWARD 1999

APPLICATIONS ARE INVITED for the 1999 Anne Harrison Award for Health Librarianship.

The Award was established over ten years ago as a tribute to the pioneering work of Anne Harrison (1923-1992) in the development of health librarianship, and is intended to encourage others to make their own contributions in this field.

The sum of \$3,000 has been made available by the Fund Trustees, and may be awarded for:

- 1. A research project which will (a) increase the understanding of health librarianship in Australia, or (b) explore the potential for further development of health librarianship in Australia
- 2. Assistance towards enrichment of knowledge and skills of Australian health sciences librarians, including funding (a) to help an ALIA member meet expenses of an approved course of study or study tour, or (b) to help meet expenses arising from a publication in the field of Australian health librarianship.

Conditions:

- 1. The Award is not limited to ALIA members
- 2. Current Health Libraries Section National Executive members are ineligible
- 3. Other conditions as set out in the Guidelines for applicants

The winner of the Award will be announced at the AGM in Hobart in August 1999.

The closing date for applications is Friday 21 May 1999.

The 8th Asia-Pacific Specials, Health and Law Librarians Conference - Strait to the future, is to be held in Hobart, Tasmania 22 –26 August 1999.

Registration Brochure released!

The registration brochure will be included in the April issue of inCite, and early bird registration closes on 25 June, so get your registration in early and save.

An exciting and innovative conference with interesting plenary speakers, papers and focus sessions is planned. The focus sessions will give delegates the chance to discuss topics of interest with experts and with each other to take advantage of their colleagues knowledge and expertise.

The health plenary speaker will be Grace Cheng ,Chief Librarian, Hong Kong Hospital Authority. Grace will speak about the "shifting information landscape" and how librarians need to reposition themselves in the world of information provision. One of the health focus sessions will be Evidence based health care – can library intervention make a difference? This is a current topic and one which will generate much interest and discussion.

As well as an interesting programme several enjoyable social events are also planned, starting with the Welcome Supper and the official opening of the Trade Exhibition on Sunday 22 August. This evening will feature a wide selection of Tasmanian food and wine and will provide an opportunity to meet colleagues and wander the trade exhibition in a relaxed atmosphere. This welcome function will be held at Wrest Point Conference Centre, the venue for the conference.

To continue the Tasmanian flavour the Monday evening delegates will be guests of the Governor, Sir Guy Green at a cocktail party at Government House. Numbers for this event are strictly limited so register early if you want to attend. The conference dinner will be held on the Wednesday evening at Hobart's City Hall and will be a "spectacular". Dinners are also planned for the Health and Law groups to take advantage of the unique venues, food and wine that Tasmania has to offer.
